And recommended at $0\,^\circ\!\mathrm{C}\text{-+}35\,^\circ\!\mathrm{C}$ for long period storage.

The capacity recovery rate in the delivery state (50% capacity of fully charged) after storage is assumed to be 80% or more.

The voltage for a long time storage shall be 3.0V~4.2V range.
